

# Privacy Policy

Portland Area Yeshe Nyingpo understands that your privacy is a necessary feature for doing business online. This Privacy Policy applies to all of the websites and products owned by Portland Area Yeshe Nyingpo. The majority of Portland Area Yeshe Nyingpo's

website is intended for a general audience and this policy describes our general use of information.

## **Collection and Use of Information**

As part of such use, you may be asked to register for a free ID and password and to provide certain personally identifying information such as name, address, phone number, email address, birth date, ZIP code, gender, personal interests and credit card information for transactions. your information to perform transactions, deliver services or information you have requested, and offer you products and services from Portland Area Yeshe Nyingpo. Portland Area Yeshe Nyingpo also uses your information to contact you when

necessary for customer service purposes. Portland Area Yeshe Nyingpo may use information relating to your visit or use of our

website, or information you provide to us, for market research purposes in order to continually improve the product and services that Portland Area Yeshe Nyingpo delivers.

If you register for a competitive event, your name, event entry identification, and interim and final event results may be made publicly available on Portland Area Yeshe Nyingpo's website. Portland Area Yeshe Nyingpo displays targeted

advertisements based on personal information or selected activities and events. Third party advertisers (including ad-serving companies) may assume that people who interact with, view, or click targeted ads meet the targeting criteria. However, Portland Area Yeshe Nyingpo does not provide any personal information to the advertiser

when you interact with or view an advertisement. Except as otherwise described in this Privacy Policy, it is Portland Area Yeshe Nyingpo's policy not to distribute to third parties any personally identifying information about you.

You may choose not to submit certain personal information while on our websites, in such instances

Portland Area Yeshe Nyingpo may not be able to provide you with certain services.

If you are using our services to register for an event, program or activity, Portland Area Yeshe Nyingpo shares the personal information you provide to applicable third party(ies) to fulfill your request. Each such party operates independently from Portland Area Yeshe Nyingpo and maintains its own privacy and security policy. Portland Area Yeshe Nyingpo bears no

responsibility from the activities of any such third party to whom Portland Area Yeshe Nyingpo provides information to process

your request and you should contact those third parties directly regarding your preferences for the use of your personal information.

Portland Area Yeshe Nyingpo has established and maintains reasonable security procedures to protect the confidentiality, security and integrity of your personally identifiable information.
